Water protection solutions for sustainable productive agriculture: practical measures for EU policy goals

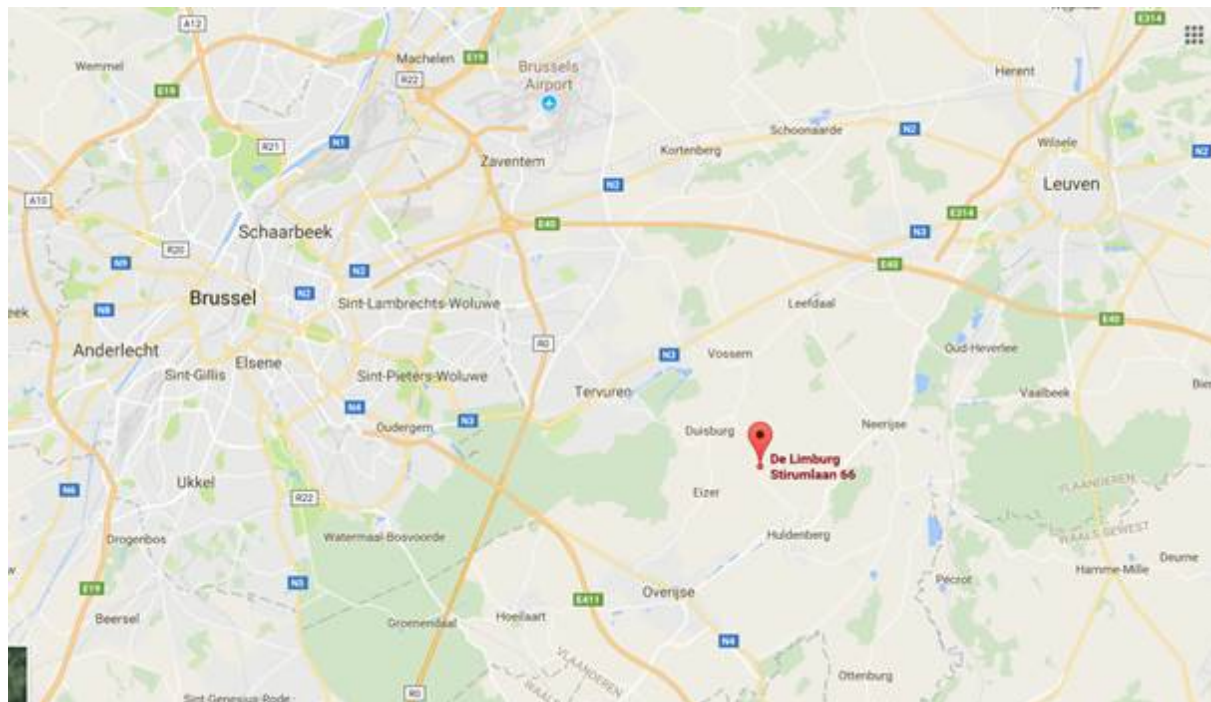
